**RULES AND REGULATIONS:**

1. The account can be opened by Proprietorship, Partnership Firms, Public or Private Companies to be operated by Authorized Signatories.
  2. Account shall be opened with a minimum balance of Rs.1,00,000/- and it is mandatory to maintain an Average Quarterly Balance of Rs.1,00,000/-
  3. The mode of operation can be singly/jointly by authorized signatories/other.
  4. Free RuPay Platinum with ATM cash limit of Rs. 35,000/- & POS of Rs. 1,00,000/- and waiver in AMC for lifetime.
  5. Free ATM transactions (3 Metro & 5 Non-Metro) on other Bank ATMs p.m.
  6. Free 250 Cheque leaves p.a. thereafter Rs. 4/- per leaf will be charged
  7. Free Internet Banking
  8. SMS banking facility for Balance Inquiry, Statement Details, Card Hot mark
  9. Free RTGS/NEFT through Internet Banking and 50 transactions of RTGS/NEFT at branch p.m.
  10. Free 50 Pay Orders p.m.
  11. Free 50 transactional SMS alerts & IMPS transactions p.m.
  12. Free Cash Deposit – 10 times of AMB per month Rs.2/- per thousand for home branch & Rs.3/- per thousand for Non-Home Branch will be charged if it goes beyond threshold limit.
  13. Concessional ROI on retail loans
  14. Accidental insurance cover of Rs. 2,00,000/-
  15. Free QR code facility
  16. POS facility available through Bank tie up
  17. All the KYC norms shall be applicable while opening the account.
  18. Penalty for non-maintenance of minimum balance charges shall be Rs.2,500/-\* per quarter and for account closure shall be Rs.1,500/-.
  19. Nomination facility available
